**NOTE:** THE ANNUAL REBATE CAP IS \$1,000 PER MEMBERSHIP.

### Rules for Applying

1. Only Farmers Electric Cooperative members are eligible for rebates on energy efficiency upgrades.
2. The annual rebate cap is \$1,000 per membership.
3. Applications must be received within the 2018 calendar year.
4. After all program requirements are met, a rebate will be issued as a bill credit to the member's account. Please allow up to 8 to 10 weeks after receipt of all documents for the rebate to be processed.
5. Farmers Electric Cooperative reserves the right to verify all projects in order to meet minimum program guidelines. The member may lose the rebate if Farmers cannot verify the information provided on the application form.
6. Submission of an application does not guarantee a rebate; funding for the program is limited. **Once funds budgeted for the rebate program are exhausted, the program ends.** Funding for all previous years is exhausted.
7. Purchase must be made in 2018 to qualify.
